- [6] AND WHEREAS the Commissioner can be dispensed from the formality of having to file a motion in support of its request to file the Amended Confidentiality Order and that the Amended Confidentiality Order can be filed with the Tribunal by letter to the Registry;

## THE TRIBUNAL ORDERS THAT:

- [7] The request to file an Amended Confidentiality Order is granted.
- [8] The Commissioner is dispensed from the requirement of filing a formal motion to file the Amended Confidentiality Order on consent and is allowed to file it by letter to the Registry.
