SCHEDULING ORDER

- [1] **FURTHER TO** the notice of application filed by the Commissioner of Competition against the Respondent for orders pursuant to section 90.1 of the *Competition Act*;
- [2] AND WHEREAS during their discussions concerning a draft scheduling order, the parties disagreed as to the time for and sequencing of their expert reports, particularly as to any efficiencies defence, which disagreement was the subject of a case management conference held on November 3, 2017;
- [3] AND FURTHER TO the Direction of the Tribunal, dated November 6, 2017, which resolved the issues raised at the November 3, 2017 case management conference and directed that certain dates be incorporated into the parties' draft scheduling order;
- [4] AND FURTHER TO the draft scheduling order provided by the parties on November 24, 2017;
- [5] **AND WHEREAS** the Tribunal has examined the proposed scheduling order and is of the view that it is appropriate and respects the principles found in subsection 9(2) of the *Competition Tribunal Act*, RSC 1985, c 19 (2nd Supp);

March 5-9, 2018	Hearing of any motions arising from Affidavits of Documents and/or productions and/or in respect of the scope of examinations for discovery
March 30, 2018	Deadline for delivery of any additional productions resulting from any Affidavits of Documents/production motions

April 16-25, 2018	Examinations for discovery according to a schedule to be settled between counsel
May 18, 2018	Deadline for fulfilling answers to discovery undertakings
May 30, 2018	Deadline for filing of motions arising from answers to undertakings and refusals
Week of June 11, 2018	Hearing of any motions arising from answers to undertakings or refusals
July 6, 2018	Last day for follow-up examinations
August 3, 2018	Applicant to serve and file documents relied upon and witness statements
	Applicant to serve and file expert reports, if any
	Applicant to serve list of documents proposed to be admitted without further proof
September 28, 2018	Respondents to serve and file documents relied upon and witness statements
	Respondents to serve and file responding reports, if any, to the Applicant's expert reports on all matters including efficiencies (s 90.1(4))
October 15, 2018	Deadline for delivering any Requests for Admissions
October 26, 2018	Applicant to serve and file list of reply documents, witness statements
	Applicant to serve and file any reply expert reports and responding report on efficiencies (s 90.1(4))
October 31, 2018	Deadline to provide documents to the Tribunal for use at the hearing (e.g., Briefs of Authorities, Agreed Books of Documents)
November 9, 2018	Respondent to file reply expert reports on matters related to efficiencies (s 90.1(4)) 3
