ORDER AMENDING THE SCHEDULING ORDER

- [1] **FURTHER TO** the notice of application filed by the applicant, the Commissioner of Competition, against the respondent, Vancouver Airport Authority, pursuant to section 79 of the *Competition Act*, RSC, c C-34, as amended;

April 10 – May 19, 2017	Examinations for discovery according to a schedule to be settled between counsel
June 16, 2017	Deadline for fulfilling answers to discovery undertakings
June 23, 2017	Last day for filing of motions arising from answers to undertakings and refusals

July 11, 2017	Mediation briefs due
July 17, 2017	Hearing of any motions arising from answers to undertakings or refusals
July 25-27, 2017	Mediation
July 31, 2017	Last day for follow-up examinations for discovery
September 20, 2017	Applicant to serve documents relied upon and witness statements, and to serve and file expert reports, if any
October 9, 2017	Applicant to serve list of documents proposed to be admitted without further proof
October 20, 2017	Respondent to serve documents relied upon and witness statements, and to serve and file expert reports, if any
October 26, 2017	Deadline for delivering any Requests for Admissions
October 26, 2017 November 3, 2017	Deadline for delivering any Requests for Admissions Applicant to serve list of reply documents and witness statements, and to serve and file reply expert reports, if any
