- [1] **FURTHER TO** the notice of application filed by the Applicant The Commissioner of Competition against the Respondent Moose International Inc. pursuant to section 74.1 of the *Competition Act*, RSC, c C-34, as amended;
- [2] AND FURTHER TO the draft scheduling order provided by the parties on July 18, 2016 and to the discussions with counsel for both parties at a case management conference held on August 4, 2016;
- [3] AND WHEREAS the Tribunal has examined the proposed scheduling order and is of the view that, with the various amendments agreed to by the parties at the case management conference, it is appropriate and respects the principles found in subsection 9(2) of the *Competition Tribunal Act*, RSC 1985, c 19 (2nd Supp.);

October 12, 2016	Deadline for delivery of any additional productions resulting from any Affidavits of Documents/production motions
October 17, 2016 – October 21, 2016	Examinations for discovery according to a schedule to be settled between counsel
October 31, 2016	Deadline for fulfilling answers to discovery undertakings
November 7, 2016	Mediation briefs due
November 19-30, 2016	Mediation (2 days)
November 25, 2016	Last day to file motions arising from answers to undertakings and refusals
November 29, 2016	Hearing of any motions arising from answers to undertakings and refusals

December 9, 2016	Last day for follow-up examinations for discovery
December 19, 2016	Applicant to serve documents relied upon and witness statements, and to serve and file expert reports, if any
January 9, 2017	Applicant to serve list of documents proposed to be admitted without further proof
January 25, 2017	Respondent to serve documents relied upon and witness statements, and to serve and file expert reports, if any
February 1, 2017	Deadline for delivering any Requests for Admissions
February 6, 2017	Applicant to serve reply documents and witness statements, and to serve and file reply expert reports, if any
February 7, 2017	Last day to file motions for Summary Disposition and/or any motions related to the evidence
February 10, 2017	Hearing of any motions for Summary Disposition and/or any motions related to the evidence
February 17, 2017	Deadline to provide documents to the Tribunal for use at the hearing (e.g., Briefs of Authorities, witness statements, expert reports and Agreed Books of Documents)
February 17, 2017	Deadline for responding to any Requests for Admissions;
