Friday, August 16, 2013	Deadline for filing motions, if any, (dealing with witness statements and expert reports)
Friday, August 23, 2013	Deadline for filing responding motion materials
Friday, August 30, 2013	Deadline for filing memoranda of fact and law
Not later than Friday, September 6, 2013	Motions in Toronto re witness statements and expert reports, if necessary

- [6] The hearing of the application will commence at 10:00 am on Monday, September 23, 2013, in the Hearing Room of the Competition Tribunal located at 600-90 Sparks Street, Ottawa, Ontario. The exact hearing dates will be fixed at a later date.
- [7] The hearing will be electronic (see Tribunal's Practice Direction regarding Electronic Hearings dated March 2011) and will proceed using chess clock timing.
