ORDER RELATING TO MATTERS CONSIDERED AT THE CONFERENCE CALL OF OCTOBER 3, 2011

- [8] Since this date is convenient for all counsel, the motions for leave to intervene filed by RS and by CREA will be heard in person on Tuesday, October 18<sup>th</sup>, 2011 at 10:00 am at 180 Queen Street West in Toronto. The Tribunal will provide the parties with the precise location of the hearing room once it has been assigned.
