- 1. An order removing Mark Nicholson and the firm Gowling Lafleur Henderson LLP as solicitors of record for Realtysellers Real Estate Inc. with respect to the above-noted proceedings;
- 2. An order enjoining Mark Nicholson and the firm Gowling Lafleur Henderson LLP from advising Realtysellers Real Estate Inc. or any related party or entity (including Mr.

Lawrence Dale) with respect to any matters arising from or related to the above-noted proceedings;

- 3. The costs of the motion on a solicitor and client basis; and
- 4. Such further and other relief as counsel may request and the Tribunal may permit.

THE GROUNDS FOR THE MOTION ARE:

- 1. During the period from approximately 2001 to mid-2007, Gowling Lafleur Henderson LLP ("Gowlings") was retained by The Toronto Real Estate Board ("TREB") as TREB's general counsel. During the period of the retainer, TREB disclosed confidential information to Gowlings relevant to subject matters in issue in the Application.
- 2. Should Realtysellers be granted leave to intervene, Realtysellers intends to support generally the position of the Commissioner of Competition, a position adverse to TREB.
- 3. Gowlings is in an actual or perceived conflict of interest.
- 4. Accepting Realtysellers' retainer has placed Gowlings in breach of its duty of loyalty to TREB.
- 5. Rules 34(1) and 83 to 88 (inclusive) of the *Competition Tribunal Rules*.
- 6. Rules 123, 400 and 401 of the Federal Court Rules.
- 7. Rules 2.04 and 2.05 of the *Rules of Professional Conduct* of the Law Society of Upper Canada.
- 8. Such further and other grounds as counsel may advise and the Tribunal may permit.
