- 5. Disclosure of the Confidential Information would result in direct harm to UCDA because this information is commercially and competitively sensitive. UCDA's competitors, 3823202 Canada Inc., carrying on business as CarProof, and CARFAX Inc. (both of which are described more fully in the application referred to above) are participants in the market for vehicle accident searches which is described in the application, and CarProof is involved in activities which are relevant to the application. Access to UCDA's detailed financial information could allow either or both of these competitors to obtain competitive advantages in the marketplace, potentially resulting in harm to UCDA's competitive position and to the purchasers of vehicle accident searches.
