**ORDER REGARDING COSTS OF CSTAR'S APPLICATION**

[1] **FURTHER TO** a notice of application filed by Canadian Standard Travel Agent Registry doing business as CSTAR on May 20, 2008, for an order pursuant to section 103.1 of the *Competition Act*, R.S.C. 1985, c. C-34, as amended (the “Act”), granting leave to make an application under section 75 of the Act (the “Application”);

[2] **AND FURTHER TO** the Competition Tribunal’s Reasons for Order and Order Dismissing an Application for Leave under Sections 103.1 and 75 of the Act (the “Reasons for Order”) dismissing the Application;
