ORDER FOLLOWING THE CASE MANAGEMENT TELECONFERENCE HELD ON APRIL 3, 2006

- [1] WHEREAS a case management conference was held on April 3, 2006;
- [2] WHEREAS the respondents filed on February 20, 2006, three motions relating respectively to the following subjects:
  - [i] Raise a constitutional question;
  - [ii] Have certain respondents removed; and
  - [iii] Have certain documents declared confidential.
- [3] WHEREAS on April 3, 2006, with the consent of the parties, a confidentiality order was issued to declare certain documents confidential;
- [4] WHEREAS the first two motions mentioned above will be heard at the beginning of the hearing on the merits of which the date is May 1, 2006;
- [5] WHEREAS the Commissioner undertakes to produce responses to the two motions on April 17, 2006;
- [6] CONSIDERING the Commissioner's motion to allow the presentation of oral testimony and the cross-examination of the affiants in the motion to have certain respondents removed and the cross-examination of the affiant in the motion to raise a constitutional question;
- [7] CONSIDERING the arguments of the parties and section 41 of the *Competition Tribunal Rules*;
- [8] AND WHEREAS the parties have agreed to prepare a draft consent concerning the admission of documentary evidence;

#### THE TRIBUNAL ORDERS THAT:

- [9] The parties will provide the Tribunal with the following information by Friday, **April 7, 2006**:
  - [i] the list of witnesses for each party;
  - **[ii]** the expected time for the examination, cross-examination and re-examination of each witness; and
  - **[iii]** the schedule for hearing the motions.
- [10] The Commissioner will respond to the motions on the constitutional question and the removal by no later than Monday April 17, 2006.
- [11] The Commissioner will file the expert reports no later than Friday, April 21, 2006, and with the consent of the parties, the Tribunal will review them before the hearing begins.

- [12] The parties will file their draft consent to the admission of documentary evidence with the Tribunal by no later than Monday, April 24, 2006. In the absence of an agreement for certain voluminous documents or exhibits, the Tribunal could hold a new case management conference in order to resolve the problem posed by the considerable number of documents and to encourage the parties to reach an agreement aimed at limiting the number of documents filed.
- [13] The Tribunal authorizes oral testimony and cross-examination of affiants at the hearing of the motion to remove, as well as the cross-examination of the affiant at the hearing of the motion to raise constitutional question, in accordance with subsection 41(2) of the *Competition Tribunal Rules*. The Commissioner must serve and file the summaries of oral testimony which will be heard at the hearing of the motion to remove no later than Wednesday, **April 26, 2006**.
- [14] Evidence heard during the hearing of the motion to remove is deemed to be part of the evidence for the hearing on the merits.
- [15] The two motions will be heard at the beginning of the hearing beginning on Monday, May 1, 2006, in Montreal in the following order:
  - [i] Motion to raise a constitutional question; and
  - [ii] Motion to remove certain respondents.
