ORDER REGARDING THE SCHEDULING OF THE PROCEEDING

- [1] The parties appeared before the Tribunal via conference call on October 27, 2005. - [2] Because of time constraints for the parties and the Tribunal, the January 9, 2006, hearing is postponed to May 1, 2006.

THE TRIBUNAL ORDERS THAT:

- [3] The hearing of the case is postponed to Monday, May 1, 2006, in Montréal, and is scheduled to take three weeks.
 - [i] The hearing will be conducted in French.
 - [ii] The documents at the hearing will be in paper format.
 - **[iii]** The Respondents will serve the expert affidavit(s) by no later than Friday, March 31, 2006.
 - [iv] The parties will serve the expert rebuttal reports by no later than Tuesday, April 18, 2006.
 - [v] The parties will file expert affidavits by no later than Friday, April 21, 2006.
 - [vi] The parties will provide to the Tribunal the documents to be submitted in evidence and file their books of authorities by no later than Wednesday, April 26, 2006.
- [4] A case management conference will be held on Friday, March 31, 2006, to finalize details for an efficient proceeding. A direction will be issued to confirm the time of the conference, which will be conducted by conference call. The parties will be asked to address the following issues during the conference call:
 - [i] each party's witness list;
 - **[ii]** the expected time for the examination, cross-examination and re-examination of each witness;
 - [iii] the preparation of an agreed statement of facts;
 - [iv] the preparation of joint documents; and
 - [v] any other measure likely to facilitate the hearing of the proceeding.
