# ORDER REGARDING THE AMENDED MOTION FILED BY THE COMMISSIONER OF COMPETITION ON DECEMBER 31, 2004

- [1] FURTHER TO the amended notice of motion filed by the Commissioner of Competition (the "Commissioner") on December 31, 2004, pursuant to section 38 of the *Competition Tribunal Rules*, SOR/94-290, and their amendments, seeking:
  - (a) An extension to complete the sale in order to give effect to the September 4, 2003, divestiture order and to restore competition in the retail market for hardware/renovation products in the Sherbrooke area; and
  - (b) An order for Rona to provide weekly inventory reports to the trustee, **[CONFIDENTIAL]**.
- [2] WHEREAS the moving party, the responding party and the third party, through their respective counsel, have agreed to this order being made by the Tribunal;
- [3] AND WHEREAS, subject to the Tribunal's jurisdiction, it is appropriate to make this order in the circumstances of this case;

#### THE TRIBUNAL ORDERS THAT:

- [4] The period during which the trustee may complete the sale is extended:
  - a) [CONFIDENTIAL], which is 14 days following the expiry of the period within which RONA may object; or
  - b) if RONA objects to the sale [CONFIDENTIAL], up to and including the 14th day following the Tribunal's order requiring RONA to complete the divestiture.
- [5] While this Order is in effect, RONA, by consent, will send the trustee the weekly inventory reports relating to the Réno-Dépôt located at 600 Jean-Paul Perreault, which may subsequently be sent to [CONFIDENTIAL], provided that the trustee also sends [CONFIDENTIAL] any additional correspondence from RONA on [CONFIDENTIAL]'s request. The trustee will not otherwise disclose the above-mentioned inventory reports.
