In 1978, I was Visiting Professor at the Graduate Institute of Economics at National Taiwan University. have served as Editor of the Journal of Business and Associate Editor of the Journal of Financial Economics and Journal of Accounting and Economics, and I am a member of the American Economic Association and Econometric Society. I have published numerous articles in scholarly journals, including the American Economic Review, the Journal of Political Economy and the Journal of Business, and I am co-author of Microeconomic Theory, a leading textbook that covers all major areas of microeconomics. In addition to my academic and administrative experience, I served in Washington as Special Assistant for Economic Affairs for then Secretary of Labor George P. Shultz and in a similar capacity at the Office of Management and Budget. I have testified as an economic expert in the District Courts of the United States and before the Federal Trade Commission.
