AFFIDAVIT OF ANDRÉ BRANTZ

I, ANDRÉ BRANTZ, public servant, of the City of Ottawa in the Regional Municipality of Ottawa-Carleton in the Province of Ontario MAKE OATH AND SAY AS FOLLOWS:

1. I am employed by the Government as a senior commerce officer on the staff of the Director of Investigation and Research ("the Director") under the <u>Competition Act</u>. I have been engaged since June of 1990 in the review by the Director of the

transactions completed on January 27, 1989 and May 8, 1990 whereby the Respondent Southam Inc. ("Southam") acquired direct and indirect control of, or a significant interest in, inter alia, 13 community newspapers, a real estate advertising publication, three flyer distribution businesses and two printing businesses operating in the Lower Mainland area of the Province of British Columbia. During the course of this review, I have received information in writing and orally from representatives of the Respondents and their counsel, as well as from others.

Accordingly, I have knowledge of the matters hereinafter deposed to.

I have reviewed the Affidavit of David Perks, dated

March 6, 1991 (the "Perks Affidavit") and filed in this action.

With respect to paragraph 8 which discusses the January 7, 1989

transaction involving North Shore Free Press, the Director, in his

March 6, 1989 letter, advised Southam that:

"The Director does not have grounds, at this time, to commence an inquiry under section 10 in respect of this transaction."

I am informed that contrary to the statement contained in paragraph 9 of the Perks Affidavit, the Director was not advised of the May 8th, 1990 transactions prior to their becoming public. The Director's office became aware of these transactions as the result of inquiries which the Senior Deputy Director of

Investigation and Research ("SDDIR") received from representatives of the media in Vancouver who were soliciting comment with respect to the transactions. The SDDIR thereupon contacted counsel for Southam (J. Quinn) who confirmed the transaction and provided him with some initial information as to the nature of the transactions. On December 3, 1990, the SDDIR was advised by counsel for the Director that counsel for Southam had requested our consent to: (i) an extension of the time for filing of a response by Southam to the Application filed with the Competition Tribunal by the Director and (ii) that the Director take no action before the Competition Tribunal by way of default or seeking an interim order, pending the determination by the Federal Court of the Southam's application for a Stay of Proceedings before the Competition Tribunal. The SDDIR instructed counsel to consent to the request. This consent was communicated to counsel for Southam in a letter dated December 4, 1990 and marked as Exhibit "H" to my Affidavit of March 4, 1991.

4. On the basis of searches conducted by Erin Hyde and Susan Julmi, articling students with Davis & Company in Vancouver, I am informed that the officers and directors of Lower Mainland Publishing Ltd., North Shore Free Press Ltd., Rim Publishing Inc., Specialty Publishers Inc. and Elty Publications Ltd. are as set out in Exhibit "A" to my Affidavit. I have always been advised by Mr. J.J. Quinn, counsel for Southam that Mr. Collison is a corporate manager of the Real Estate Weekly.
